

QUIT CLAIM DEED

THIS INDENTURE, Made this 13<sup>th</sup> day of November, 1969, between GEORGE B. BENNETT as Adjutant General of the State of Idaho, Grantor, and the IDAHO STATE UNIVERSITY, acting by and through the Idaho State Board of Education and the Board of Regents of the University of Idaho, acting as Board of Trustees for Idaho State University, a public corporation, Grantee:

FOR VALUE RECEIVED, Grantor does hereby convey, release, remise and forever quit claim unto the Grantee the following described premises, situate in Bannock County, Idaho, pursuant to Chapter 228, Idaho Session Laws of 1963, to-wit:

Lot Five (5), Six (6), Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11), Twelve (12), Thirteen (13), Fourteen (14), Fifteen (15) and Sixteen (16), in Block Three Hundred Sixty-one (361) of the Pocatello Townsite, in Idaho, and

Lot Five (5) in Block Three Hundred Ninety-eight (398) of the Pocatello Townsite, in Idaho, according to the official Plat of the Survey of the said lands, returned to the General Land Office by the Surveyor General;

Together with their appurtenances.
